To the extent these customers economic or bypass alternative changes, the Company would then conduct a new economic analysis. All special contract customers have maintained their bypass alternatives and therefore the Company has not conducted any new analysis.

The Company is aware that the frequency and inclusion of Special Contracts is an on-going issue being discussed in the Cost of Service Rule Making Dockets (UE-170002 and UG-170003). The Company looks

forward to continuing to work with the parties in the formal rule making setting to formalize the requirements around Special Contracts.
