**Re: UT-100203 Notification Letter - Sprint Corporation, Virgin Mobile USA, L.P.
(Assurance Wireless) regarding service offering enhancements**

Dear Mr. King,

In accordance with UT-100203, Order 01, Appendix B #3, Sprint Corporation (Sprint), Virgin Mobile USA, L.P. (Virgin Mobile), operating under the brand Assurance Wireless (“Assurance Wireless”), hereby notifies the Washington Utilities and Transportation Commission (Commission) of two service plan offering upgrades, effective December 1, 2017. First, Assurance Wireless is amending its broadband Lifeline offer to reflect 1GB of data per month. Existing Lifeline broadband customers will receive this new offer based on their normal service cycle by December 1, 2017, with all broadband Lifeline subscribers migrated to the new plan by December 1, 2017. New Lifeline broadband customers will receive this offer by December 1, 2017. Second, Assurance Wireless is amending its voice-only Lifeline offer to include 750 domestic voice minutes and unlimited text messages by December 1, 2017. Existing customers will migrate beginning November 2017 and no later than December 1, 2017. This revised offer for Assurance Wireless Lifeline customers is necessary in order to comply with new minimum Federal Communications Commission (“FCC”) Lifeline service standards effective December 1, 2017.

As of December 1, 2017 Virgin Mobile must ensure that Assurance Wireless Lifeline customers receive the benefit of a Lifeline offer that meets the FCC’s new minimum service standards in order for the Parties to qualify for the \$9.25 federal Lifeline subsidy for those customers.
