**I. DISCUSSION**

The Fifth Amended Exhibit A of the SGAT is being amended to reflect the rates filed in the Part B and Part D Compliance filings in Docket UT-003013, Continued Costing and Pricing Proceeding for Interconnection, Unbundled Network Elements, Transport and Termination, and Resale. The rates were approved by the 50th Supplemental Order for the Part B Compliance Tariff Filing (dated May 15, 2003) and the Fifty-First Supplemental Order for the Part D Compliance Tariff Filing (dated June 16, 2003). Additionally, some administrative changes have been made. The Exhibit A is provided in both “clean” and “redline” version to facilitate review.

**II. CONCLUSION**

For the foregoing reasons, Qwest respectfully requests that the Commission allow this version of Exhibit A to the SGAT to become effective concurrent with the approved compliance tariffs.
