Pursuant to WAC 480-07-460(1)(ii), please find enclosed the revised Response Testimony of Bradley G. Mullins (Exhibit BGM-1CTr) on behalf of the Alliance of Western Energy Consumers (“AWEC”) in the above-referenced docket. For ease of reference, AWEC is filing both redlined and clean copies of Mr. Mullins’ revised Response Testimony. The revisions have no substantive impact on Mr. Mullins’ Response Testimony.

AWEC includes an errata list below, detailing the above-mentioned revisions:

- BGM-1CT at 8, Table 1 – adding explanatory note clarifying that “NMF” in table 1 stands for “No Meaningful Figure.”
- BGM-1CT at 16:12 – correcting “east-side” to “west-side”
- BGM-1CT at 23:19 – inserting “gas” before plants for clarity.
- BGM-1CT at 54:8-9 – correcting aMW from “sales” transactions to “purchase” transactions.
- BGM-1CT at 55:6 – correcting net “long” position to net “short” position.
- BGM-1CT at 56:6 – correcting net “long” position to net “short” position.

Please note that AWEC’s Response Testimony contains information that PacifiCorp has designated as confidential per the Protective Order in this proceeding. Accordingly, AWEC has designated this information as confidential pursuant to WAC 480-07-160 and the Protective Order in WUTC Docket UE-230482.
