NOTICE OF PREHEARING CONFERENCE (Set for August 4, 2022, at 9:30 a.m.)

- On June 29, 2022, Puget Sound Pilots (PSP) filed with the Washington Utilities and Transportation Commission (Commission) proposed revisions to its currently effective Pilotage Tariff No. 1. PSP characterizes this filing as a general rate case.
- On July 15, 2022, the Commission entered Order 01, Complaint and Order Suspending Tariff Revisions. The Commission suspended the operation of PSP's tariff revisions and initiated an adjudication in this proceeding.
- STATUTORY AUTHORITY: The Commission has jurisdiction over this matter under Title 80 RCW and Title 81 RCW, and has legal authority to regulate marine pilotage services. The statutes that apply to this matter include Chapters 80.01 RCW, 80.04 RCW, 81.116 RCW, and 88.16 RCW relating to rates, including but not limited to RCW 80.01.040, RCW 80.04.020, and RCW 88.16.055. The rules that apply to this matter include those within Chapters WAC 480-160, relating to marine pilotage services.
- The Commission will hear this matter under the Administrative Procedure Act (APA), particularly Part IV of Chapter 34.05 RCW relating to adjudications. The provisions of the APA that relate to this proceeding include, but are not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission will also follow its procedural rules in WAC 480-07 in this proceeding.
- The Commission finds there is good cause to hear this matter on shortened notice. *See* WAC 480-07-440(1)(a) and RCW 34.05.434.

The Commission will consider oral petitions to intervene during the conference, but strongly prefers written petitions to intervene. Party representatives must file a notice of appearance with the Commission no later than the business day before the conference. See WAC 480-07-345(2). Any party or witness in need of an interpreter or other assistance should fill out the form attached to this Notice and return it to the Commission. The Commission will set the time and place for any evidentiary hearings at the prehearing conference, on the record of a later conference or hearing session, or by later written notice.
