TO ALL INTERESTED PERSONS:

On July 18, 2001, the Washington Utilities and Transportation Commission (Commission) filed a Supplemental CR-102 (WSR#01-15-088) with the Code Reviser that proposes the repeal of WAC 480-90-121. A copy of the Supplemental CR-102 is enclosed.

A new rule, WAC 480-90-123, proposed in a prior Supplemental CR-102 (WSR# 01-11-148), filed on May 23, 2001, is intended to replace WAC 480-90-121. The purpose of this Supplemental CR-102 is to correct an incorrect repealer in the May 23rd Supplemental CR-102. The May 23rd Supplemental CR-102 listed WAC 480-90-116 as the repealer instead of WAC 480-90-121.
