TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission has filed with the Code Reviser proposed revisions to the adoption-by-reference rules in Title 480 of the Washington Administrative Code (WAC). The Commission filed the proposed changes as an expedited rulemaking (CR-105) under Docket No. A-030852.

This proposal would revise adoption-by-reference dates to reflect the most current published versions of adopted publications as well as make other minor administrative changes.
