- On July 8, 2005, Gateway Shuttle Service, Inc. (Gateway Shuttle) filed an application with the Commission, No. D-079387, for a Bus Certificate (Application).¹ Notice of the Application was published in the Commission's weekly Docket of August 1, 2005.
- Gateway Shuttle's application requests authority to provide door-to-door passenger service, by reservation only, between 1) Clallam and Jefferson Counties, and Seattle and Tacoma hospitals, Amtrak stations, Greyhound stations, and the Seattle-Tacoma International Airport with flag stops in Kitsap County with closed door service between Clallam and Jefferson Counties, and the indicated points in King and Pierce Counties, and closed door service between Kitsap County and Seattle-Tacoma International Airport,² and 2) Clallam and Jefferson Counties and Port Townsend, Port Ludlow, and Silverdale, for passengers whose point of origin or point of destination is in Clallam or

Jefferson County. All passengers transported by Gateway Shuttle must have either their origin or their destination in Clallam or Jefferson County.³ The Application requests the following condition:

Gateway Shuttle may not provide service to passengers from any point served by Heckman Motors, Inc., d/b/a Olympic Bus Lines, under Certificate No. C-992 without advance reservations made at least one hour in advance of the pick-up times at each such point indicated by Heckman Motors schedule as published from time-to-time in accordance with WAC 480-30-060.

The Application requests approval that Gateway Shuttle be authorized to operate a five foot by eight foot trailer when the trailer is used to carry baggage or express and is towed by a vehicle transporting passengers. Gateway Shuttle has filed proposed tariffs and schedules describing the conditions under which it intends to provide the proposed service.

- The Commission has jurisdiction over this matter under Title 81 RCW, having legal authority to regulate persons seeking to furnish auto transportation services under chapter 81.68 RCW. The issues in this proceeding include whether granting the Application would be consistent with the foregoing statutes and otherwise consistent with the public interest.
- The statutes involved include those within chapter 81.04 RCW, chapter 81.68 RCW, and chapter 34.05 RCW, including but not limited to RCW 34.05.422, RCW 34.05.440, RCW 34.05.449, RCW 34.05.452, RCW 81.68.030, RCW 81.68.040, and RCW 81.68.070. Rules involved include those within chapter 480-07 WAC, chapter 480-30 WAC, including but not limited to WAC 480-30-020 and WAC 480-30-030.
