## SIXTH AMENDMENT TO SALE AND PURCHASE AGREEMENT

THIS SIXTH AMENDMENT TO SALE AND PURCHASE AGREEMENT (the "Amendment") is made and entered into as of this 28 day of October, 2005, by and between BRCP QWEST SEATTLE I, LLC, a Delaware limited liability company ("Buyer"). and QWEST CORPORATION, a Colorado corporation ("Qwest").

This Amendment may be executed in counterparts and, when counterparts of this Amendment have been executed and delivered by both of the parties as 3. provided in this Section 3, this Amendment shall be fully binding and effective, just as if both of the parties had executed and delivered a single counterpart of this Amendment. Without limiting the manner in which execution of this Amendment may be accomplished, execution by either party may be effected by facsimile transmission of a signature page of this Amendment executed by such party. Any party who effects execution by facsimile transmission of a signature page shall also promptly deliver to the other party a counterpart physically signed by such party, but the failure of any party to furnish such physically-signed counterpart shall not invalidate the execution of this Amendment effected by facsimile transmission.
