Nature of Proceeding. Docket No. UT-051602 is a formal complaint filed by Network Essentials, Ltd. (Network Essentials) against the Grant County Public Utility District No. 2 (Grant County PUD), and Docket No. UT-051742 is a formal complaint filed by bigdam.net against the Grant County PUD. Both Complaints ask that the Commission review Grant County PUD's rate policies pertaining to wholesale telecommunications services.

- Prehearing Conference Order. The Commission entered Order No. 01— Prehearing Conference Order on January 10, 2006, and consolidated the dockets for purposes of hearing.
- After entry of the prehearing conference order, Grant County PUD sought clarification of the briefing schedule for Motion(s) for Summary Determination. The PUD believes it was determined that the District's motion, to be filed by February 28, would be limited to the issues raised in the bigdam.net claim, and the issues in the Network Essentials claim were to be scheduled and considered following the February 28 prehearing briefs as scheduled.
- Grant County PUD asks that the order be clarified by referencing Docket No. UT-051742 and providing that the Motion for Summary Determination will be in relation to issues raised in the bidgam.net complaint and issues relating to the Network Essentials claim will be scheduled and considered following the February 28 prehearing Briefs. In addition, Grant County PUD asks that the Commission service list include Mr. Ray A. Foianini in addition to Mr. Michael W. Smith as representing the District.

## **ORDER**

- 5 Order No. 01 in this proceeding is clarified as follows:
- The Commission recognizes Mr. Ray A. Foianini's appearance and the Parties' Representatives list is amended to include him as counsel representing Grant County Public Utility District No. 02. An updated service list is attached as Appendix A.
