PETITION OF COMCAST PHONE OF WASHINGTON, LLC TO INTERVENE

Comcast Phone of Washington, LLC d/b/a Comcast Digital Phone ("Comcast") pursuant to Wash. Admin. Code 480-07-355 and the Notice of Conference Hearing issued by the Washington Utilities and Transportation Commission ("Commission"),<sup>1/</sup> hereby petitions to intervene in the above-captioned docket. Embarq Corporation and CenturyTel, Inc. (collectively, the "Applicants") claim that their merger warrants little attention from this Commission. To the contrary, the merger could undermine the consumer benefits brought by voice competition, particularly to consumers in rural areas. As one of the applicant's prime

competitors whose ability to serve rural consumers is directly impacted by the proposed merger, Comcast petitions to intervene and provides the following information.

1. Comcast Phone of Washington, LLC is a Delaware limited liability company with its principal place of business in Philadelphia, Pennsylvania.

2. Comcast is a facilities-based telecommunications company authorized by the Commission to provide competitive local exchange services throughout the State of Washington. Comcast, through its various affiliates, currently competes with the Applicants in the provision of voice, broadband, and video services. In order to offer this competitive choice, Comcast must be able to interconnect with the Applicants on reasonable, non-discriminatory terms. The merger heightens the incentives and ability of the Applicants to withhold such interconnection or to otherwise hinder their competitors, in turn undermining competition and denying consumers, particularly rural consumers, the ability to choose their service provider. Comcast, thus, has a direct and vital interest in ensuring that the potential of the proposed merger to harm competition is fully assessed.
