 Commission Staff's Response to Proposed Payment Schedule

Dear Mr. King:

On July 11, 2017, the Washington Utilities and Transportation Commission (Commission) issued Order 01 in Docket TV-170205 which assessed a penalty of \$21,100 against Iron Man Movers and Storage, Inc., (Iron Man) for violations of Washington Administrative Code 480-15-490 and Tariff 15-C. The Commission suspended \$10,600 of the penalty on conditions outlined in Order 01. This left a balance of \$10,500 due and payable to the Commission.

On September 26, 2017, Iron Man, contacted staff and proposed a payment plan. The plan consists of 21 payments of \$500.

Staff supports the payment plan proposed by Iron Man, under the following conditions:

- 1. Iron Man will make 21 individual payments of \$500, for a total of \$10,500.
- 2. Each payment will be due and payable on the 5th business day of each month, beginning with a payment of \$500 due October 6, 2017.

3. If the company fails to pay any installment by the due date or fails to pay at least the minimum amount due, the entire remaining balance of payments and the suspended penalty will become immediately due and payable.

The proposed payment scheduled is depicted below:
