ORDER ACKNOWLEDGING  
CHANGE IN CORPORATE NAME

**BACKGROUND**

- 1 On June 1, 2018, Shirona Water Company, LLC (Shirona or Company) filed with the Washington Utilities and Transportation Commission (Commission) proposed tariff revisions that would increase annual revenues by four percent. As part of the filing, the Company notified the Commission of a change in its corporate name to Wildwood Water Company, LLC.
- 2 The Company's office is located near Oak Harbor, and it serves approximately 228 customers in Island County. The Company serves two water systems named Shirona (ID# 78373) and Crosswoods (ID# 16274 J).
- 3 Staff recommends that the Commission acknowledge the utility name change. The Company properly registered the name change with the Washington Secretary of State. In addition, the change in corporate name request does not involve a change in the ownership, management or control of operating authority of the Company.

**DISCUSSION**

- 4 The Commission acknowledges that the Company timely notified the Commission of the utility name change. Pursuant to WAC 480-30-133, a utility must file a tariff adoption notice with the Commission when a utility name change affects an existing tariff. The tariff adoption notice may be made effective on one day's notice, and must be filed within one year of the name change. We conclude that the Company has met these requirements.

### FINDINGS AND CONCLUSIONS

- 5 (1) The Commission is an agency of the State of Washington vested by statute with the authority to regulate rates, rules, regulations, practices, accounts, securities, and transfers of public service companies, including water companies.
- 6 (2) Shirona is an investor-owned water company and is a public service company subject to the jurisdiction of the Commission.
- 7 (3) On March 13, 2018, Shirona filed an Amended Certificate of Formation with the Washington Secretary of State to change its name to Wildwood Water Company, LLC.
- 8 (4) On June 1, 2018, Shirona proposed revisions to its currently effective tariff. As part of the filing, the Company notified the Commission of its change in corporate name to Wildwood Water Company, LLC. T
- 9 (5) This matter was brought before the Commission at its regularly scheduled meeting on August 30, 2018.
- 10 (6) After reviewing the tariff revision filed in Docket UW-180492 by Shirona on June 1, 2018, the Commission acknowledges the change in corporate name from Shirona Water Company, LLC to Wildwood Water Company, LLC.

**ORDER**

**THE COMMISSION ORDERS THAT** by this Order, the Commission acknowledges Shirona Water Company, LLC's corporate name change to Wildwood Water Company, LLC.
