RATE INCREASE NOTICE FOR LEWIS COUNTY ROLL-OFF SERVICE

Dear Customer:

July 31, 2020

Harold LeMay Enterprises, Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC November 1, 2010. Since that time, the Company has experienced higher costs for employee wages, benefits, fuel, truck equipment and has purchased additional capital assets.

If approved by the WUTC, the proposed rates will become effective September 1, 2020.
