RE: *Washington Utilities and Transportation Commission v. Americam Movers LLC*  
Commission Staff's Response to Request for Payment Arrangement  
Docket TV-230696

Dear Ms. Hunter:

On October 3, 2023, the Washington Utilities and Transportation Commission (Commission) issued a penalty assessment against Americam Movers LLC, (Americam Movers or Company) in the amount of \$5,400 for violations of Washington Administrative Code (WAC) 480-15-530, Public Liability and Property Damage Insurance, WAC 480-15-550, Cargo Insurance, and WAC 480-15-560, Vehicle and Driver Safety Requirements, which adopts Title 49 Code of Federal Regulations (49 C.F.R.) 49 C.F.R. Part 391 – Qualification of Drivers, and 49 C.F.R. Part 396 – Inspection, Repair, and Maintenance.

On January 19, 2024, the Commission entered Order 01, which reduced the penalty to \$4,850, subject to conditions. Order 01 required the Company to pay the \$4,850 penalty or file a mutually agreeable payment plan with Staff within 10 days.

On January 23, 2024, Commission staff (Staff) and Americam Movers came to a mutual agreement on a proposed payment plan, as follows:

Staff recommends the Commission grant the Company's request for payment arrangements. Americam Movers is aware that if it fails to pay any installment by the due date, the entire remaining balance will immediately become due and payable without further Commission order.
