**NOTICE OF OPPORTUNITY TO RESPOND**  
**(Due by July 12, 2022)**

RE: *Washington Utilities and Transportation Commission v. PacifiCorp, d/b/a Pacific Power & Light Company*

On June 6, 2022, the Washington Utilities and Transportation Commission (Commission), through its staff (Commission staff), issued a Complaint and Notice of Prehearing Conference in Docket UE-220376 (Complaint). The Complaint alleges that PacifiCorp, d/b/a Pacific Power & Light Company (PacifiCorp or Company) violated Commission Order 01 in Docket UE-210829, Revised Code of Washington (RCW) 19.280.030(3)(a)(ii), RCW 19.280.030(3)(a)(iii), Washington Administrative Code (WAC) 480-100-640(7), and WAC 480-100-660(4). Staff requested the Commission find PacifiCorp in violation of statute, Commission rule, and Commission order and assess a penalty of \$1,000 per day for each of the five violations alleged. In the Complaint, the Commission also set a prehearing conference for June 30, 2022, at 1:30 p.m., during which the Commission will decide which, if any, petitions to intervene should be granted.

On June 27, 2022, PacifiCorp timely filed an Answer, a Motion to Stay Penalties, and a Motion to Dismiss.

On June 28, 2022, Staff filed a Motion to Consolidate Docket UE-220376 with Docket UE-210829, which contains the Commission order Staff alleges PacifiCorp has violated.

Commission rules require the filing of any responses within five business days for the Motion to Consolidate and the Motion to Stay Penalties and any responses to the Motion to

Dismiss within 10 calendar days or at such other times as the presiding officer or Commission may set.<sup>1</sup>

Due to the upcoming prehearing conference and holiday, the efficient use of Commission resources, and the number and significance of the issues involved, the Commission finds good cause to afford parties until July 12, 2022, at 5 p.m. to respond to the Motion to Consolidate, the Motion to Stay Penalties, and the Motion to Dismiss.

**THE COMMISSION GIVES NOTICE That any party intending to respond to the Motion to Consolidate, the Motion to Stay Penalties, or the Motion to Dismiss must file a written response by July 12, 2022, at 5 p.m.**
