TO ALL INTERESTED PERSONS:

On March 20, 2013, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider possible additions or modifications to certain sections in Washington Administrative Code (WAC) Chapter 480-07, the Commission's procedural rules. On February 28, 2017, the Commission entered General Order R-588, Order Amending, Repealing and Adopting Rules Permanently in this docket modifying the rules in Parts I, II, and III A in WAC 480-07 effective March 31, 2017.

Commission staff has developed draft proposed rules for Part III B for review and comment by interested persons. The draft rules are available for inspection on the Commission's website at [www.utc.wa.gov/130355](http://www.utc.wa.gov/130355).
