4. The administrative rules at issue are WAC § 480-07-340, -355.

5. Walmart is a large retailer with 66 retail units in Washington with over 23,000 associates.1 Walmart is a commercial customer of Avista Corporation d/b/a Avista Utilities ("Avista"), owning and operating 8 stores within Avista's Washington service territory.

6. Walmart has a direct, immediate, and substantial interest in Avista's proposed new rates and this proceeding as a customer of Avista. The interests of Walmart will not be adequately represented by any other party to this proceeding.

7. The rate Walmart pays for electric service and gas service from Avista in Washington will be affected by a Commission decision in this proceeding.

8. Walmart has not yet determined the extent of its participation or the precise nature of the relief it will request but anticipates participating in this matter to the extent necessary to ensure its interests in Washington are protected. The interests of justice and the orderly and prompt conduct of this proceeding will not be impaired by the grant of Walmart's Petition to Intervene.
