TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission) is examining whether new or revised regulations are needed in the household goods carrier industry.

Competition continues to increase in this industry. Some of the Commission's rules, designed to regulate strictly every aspect of the industry, may no longer be appropriate. It may be time to revise the rules and design them to fit the new marketplace and the new industry.

In addition to revising the rules, the Commission may also revise the household goods tariff (Tariff 15-B). The Commission can not change rules unless it also changes the associated tariff, as the tariff puts many of the rules into effect.
