The allegations brought against the Bremerton-Kitsap Airporter, Inc. by the Washington Utilities & Transportation Commission Order 02 are utterly and completely false. All of the information sent to the commission indicates this falsehood. I, Cory Dame ACCIDENTLY initially mistook <u>hire</u> dates for <u>driving</u> dates in the case of Mr. Rupright and Mr. Legister. Original copies of the time cards for both William Rupright and Gregory Legister confirm that neither driver drove solo runs prior to receiving negative drug test results as shown on enclosures.

On July 1, 2015 BKA filed our request for review of the alleged infractions in Order 01. The original time card for Gregory Legister was <u>NEVER</u> altered in any way. The comments noted on the <u>COPY</u> of the time card submitted to you, by me, were to help point out the time line indicated in paragraph 4 of our letter of July 1, 2015.

I again reiterate that neither driver drove solo before negative drug test results were received.


