RATE INCREASE NOTICE FOR RESIDENTIAL GARBAGE, RECYCLING AND YARD WASTE

Harold LeMay Enterprises, Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC August 1, 2012. Since that time, the Company has experienced higher costs for employee wages, benefits, fuel, truck equipment and has purchased additional capital assets..

If approved by the WUTC, the proposed rates below will become effective August 1, 2019.
