Pursuant to Section 1 of Engrossed Substitute Senate Bill 5295, the Washington Utilities and Transportation Commission (Commission) is required to "conduct a proceeding to develop a policy statement addressing alternatives to traditional cost of service ratemaking, including performance measures or goals, targets, performance incentives, and penalty mechanisms."

Phase 1 of this proceeding will establish design principles, as well as regulatory goals and outcomes, and will identify performance metrics. At the end of Phase 1, the Commission will issue a policy statement, anticipated by March 2023, that incorporates stakeholder feedback on these issues.
