RATE INCREASE NOTICE FOR LEWIS COUNTY ROLL-OFF SERVICE

Dear Customer:

March 15, 2024

Harold LeMay Enterprises, Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC September 1, 2020. Since that time, the Company has experienced higher costs for employee wages, benefits, fuel, truck equipment and has purchased additional capital assets.

If approved by the WUTC, the proposed rates below will become effective May 1, 2024.

You will have an opportunity to provide your comments at this meeting either in person or remotely.
