The Public Counsel Unit of the Washington Attorney General's Office (Public Counsel) hereby offers this Public Comment Exhibit Bench Request No. 11 (BR-11) for admission into the record for this proceeding in consolidated Dockets UE-220066, UG-220067, and UE-210918 concerning the Puget Sound Energy's (Company) Petition to Amend Final Order 24. On January 19, 2024, the Washington Utilities and Transportation Commission (UTC or Commission) issued a Notice of Virtual Public Comment Hearing (Notice), which was scheduled for 6 p.m. on February 8, 2024. The Commission and Public Counsel both receive and compile remarks from customers in response to the Company's Customer Notice. Customers can provide comments to Public Counsel via email or phone call. In addition, customers can also comment directly with

the Commission through its online comment web portal, calling into their office, or by emailing them.

- 2. Public Comment Exhibit No. BR-11. The Commission's Consumer Protection and Communications Staff documented 210 customer comments in a database matrix. The output from this database is included in .pdf format as Attachment 1 to this exhibit. In addition, one customer provided an attachment to their emailed comments, this is included as Attachment 2. These files contain all comments submitted to the Commission.³ The Public Counsel Unit received 30 comments either through email or by phone, and these comments are included in Attachment 3.⁴ In addition, Public Counsel is also supplying an accumulative tally that totals their received comments and compares them to ones received by the Commission. For the totality of evidence we have included all comments received by Public Counsel in Attachment 3, however we excluded the duplicative comments from the count listed below.⁵
- 3. The database matrix in Attachment 1 contains all comments submitted to the Commission through their online web portal, via email, or by phone in response to the Notice up to the
