
**RESPONSE TO ADMINISTRATIVE LAW JUDGE  
BENCH REQUEST 1**

*I.* PacifiCorp dba Pacific Power & Light Company (PacifiCorp) provides this response to Judge O’Connell’s Bench Request dated February 21, 2020.
