WAC 480-120-414 Emergency operation.

(1) All companies must maintain, revise, and provide to the commission the following:

- (a) The titles and telephone numbers of the company's disaster services coordinator and alternates; and

- (b) Upon request of the commission, the company's current plans for emergency operation, including current plans for recovery of service to governmental disaster recovery response agencies within the state of Washington.
Z-Tel Communications, Inc. is a UNE-P provider and in-state disaster relief is provided by the companies from which we lease facilities. The Enterprise Control Center(ECC) has provided procedures and conducts regular monthly drills for relocation of the ECC (which includes the 24/7 Network Operations Center NOC). These procedures and associated Support systems are for the ECC/NOC function which supports telephony, web/data, provisioning and other customer affecting systems.
