4 the state of Washington, or a default judgment may be entered against
5 you without notice. A default judgment is one in which the Petitioners
6 are entitled to what they ask for because you have failed to respond to
7 the Complaint. If you serve your notice of appearance on the
8 undersigned attorney for the Petitioners, you are entitled to be heard
9 before a default judgment may be entered.

10 You may demand that the Petitioners file this lawsuit with the
11 court. If you do so, the demand must be in writing and must be served
12 upon the Petitioners. Within fourteen (14) days after you serve the
13 demand, the Petitioner must file this lawsuit with the Court or the

17 served on time.


