- 3. On March 16, 2000, I coordinated with Fleet Foot for the filing of the Petition for Reconsideration in the above docket, with the Commission.

- 4. I informed Fleet Foot that the document would be ready for a 1:00 p.m. pickup and would need to be delivered to Olympia by no later than 4:30 p.m. for filing with the Commission that same day.
- 5. The courier picked up our package at 1:30 p.m. I called the WUTC Records Center at 4:30 p.m. to confirm delivery but was told that the document had not arrived.

Re: Letter of Explanation

This letter is in reference to the mishandled delivery to Olympia of March 16, 2000.

The first error occurred when Deb from PSE called in to advise us that the package would be ready for delivery at noon rather than 1:30 PM as originally planned. The Customer Service Agent taking the call did not reschedule the job appropriately. The CSA has been counseled on the proper protocol.

The second error occurred when the courier to whom the job was assigned misread the address on the package and took the job to the wrong building.
