The tariff associated with this docket was filed on May 10, 2006. On September 27, 2006 rate relief was granted per revisions filed on September 25, 2006. The effective date was September 28, 2006.

Item 6 as identified in the background of order 02 states that a pro forma adjustment of \$146,212 had been allowed for new employees that had not yet been hired. April 9, 2007 the last of these employees was hired.

The monthly accrual to the Regulatory Asset account was projected to be \$12,184. Allowances were made for excess overtime as verbally approved by Mr. Kermode our then auditor. Adjustments were made for wages paid to the new hires. The following spreadsheet shows the details of these entries. Customer count as of April 30th showed 15,658 customers. The company had calculated a refund of 51 cents per customer. A pre-audit by commission staff shows a calculation error in the January entry. WWSC is in agreement with this change and the new amount to be refunded will be 54 cents per customer.

The refund to customers will show as a one time credit on their bill.
