Re: PacifiCorp's RY2 Compliance Filing – Order 08/06, Revisions to PacifiCorp's General Tariffs

Dockets UE-230172 and UE-210852

Dear Jeff Killip:

On March 19, 2024, the Washington Utilities and Transportation Commission (Commission) entered Order 08/06 in these consolidated dockets. Order 08/06, among other things, rejected the tariff revisions filed by PacifiCorp d/b/a Pacific Power & Light Company (PacifiCorp or Company) in Docket UE-230172 and approved a multi-party settlement to resolve the Company's 2023 general rate case.

On March 7, 2025, PacifiCorp filed revised tariff sheets for Tariff WN U-76. Those tariff sheets, which are listed on the attachment to this letter, will become effective April 3, 2025, for Rate Year 2 of the Company's multi-year rate plan.

Order 08/06 authorized a revenue requirement increase of \$21.1 million to PacifiCorp's base rates for Rate Year 2. Consistent with the order, PacifiCorp has updated its net power cost forecast, and this results in a revised revenue requirement increase of \$15.8 million. The average residential customer using 1,200 kWh per month will see an increase of \$5.94 per month.

Schedule 92 contains the adjustment for both the Coal Facilities Tracker identified in paragraph 13 of Attachment A to Order 08/06 and the Fly Ash tracker identified in paragraph 16 of that same attachment. The proposed tariff sheets support the updated revenue requirement increase, including an update to Schedule 92, Temporary Coal Cost Adjustment, which is a tracker established in the Settlement Stipulation for recovery of non-NPC costs associated with coal-fired facilities.

Commission Staff (Staff) has reviewed the Company's compliance filing. Staff believes that the revised tariff pages comply with Order 08/06.
