RE: *Washington Utilities and Transportation Commission v. Avista Corporation, d/b/a Avista Utilities*,  
Docket UE-240891

TO ALL PARTIES:

On October 31, 2024, Avista Corporation d/b/a Avista Utilities (Avista or Company) filed with the Washington Utilities and Transportation Commission (Commission) proposed revisions to its rates under electric Tariff WN U-28, Schedule 99 – Colstrip Tracker. This matter came before the Commission at its December 19, 2024, Open Meeting.

On December 20, 2024, the Commission entered Revised Order 01 (Order 01) in the above-referenced docket.<sup>1</sup> In Order 01, the Commission found that the tariff revisions Avista filed on October 31, 2024, might injuriously affect the rights and interests of the public,<sup>2</sup> but found good cause to allow the proposed rates to go into effect on January 1, 2025, subject to later review and refund pending the Commission’s final determination in this matter.<sup>3</sup> Accordingly, Order 01 directed Avista to file revised tariff pages no later than December 23, 2024, with an effective date of January 1, 2025, indicating that the revised rates are subject to refund pending the Commission’s final determination of this matter.<sup>4</sup>

On December 20, 2024, Avista filed revised tariff sheets in Docket UE-240891, as required by Order 01.

On December 23, 2024, Commission staff (Staff) filed a letter in this docket indicating that Staff had reviewed Avista's compliance filing of revised tariff sheets and is satisfied that the revised tariff pages include the added language required by Order 01.

The Commission agrees with Staff's assessment that Avista's December 20, 2024, compliance filing complies with the terms of Order 01 directing Avista to file revised tariff pages. Therein, the revised tariff pages are approved to become effective on January 1, 2025.
