

TO ALL PARTIES OF RECORD:

The Commission entered its Order Consolidating Proceedings; Prehearing Conference Order in this proceeding on December 18, 2000. This errata notes and corrects three errors in that Order, as follows:

Paragraph 1 of the Order is corrected to state that “The Commission convened a prehearing conference in Docket No. UE-001952 in Olympia, Washington on December 14, 2000 . . .”

Paragraph 3 of the Order is corrected to state that “The following persons petitioned to intervene in these proceedings: Public Utility District No. 1 of Whatcom County; City of Anacortes; Bellingham Cold Storage Company; and the Association of Western Pulp and Paper Workers (AWPPW).”
