In the extensive discussions that have taken place regarding revisions to WAC 480-100-123, PacifiCorp has supported establishing some limitations surrounding the use of prior obligation in the State of Washington. The Company appreciates the Commission Staff's proposal to limit the use of prior obligation to residential customers no more than three times per calendar year. Of the four alternatives sent for comments, PacifiCorp prefers Options 2 and 3 due to the proposed limitations on the use of prior obligation.
