TO ALL PARTIES:

On February 29, 2024, Cascadia Water, LLC (Cascadia Water or Company) filed with the Washington Utilities and Transportation Commission (Commission) tariff revisions that would generate approximately \$1,788,793 (75 percent) additional annual revenue. The Company serves approximately 4,000 customers. The Company's last general rate case was effective July 1, 2021, with phased-in rates.

On June 27, 2024, this matter came before the Commission at its regularly scheduled open meeting.

On June 28, 2024, the Commission issued Order 01 Complaint and Order Suspending Tariff Revisions (Order 01) in Docket UW-240151. Order 01 set the matter for adjudication.

On September 11, 2024, the Commission issued Order 02, Prehearing Conference Order and Notice of Hybrid Evidentiary Hearing (Order 02), which established a procedural schedule. The procedural schedule allowed for two public comment hearings to be scheduled at a later date.
