Description of amendment:

Amends the agreement reflecting implementation of the FCC’s Forbearance Orders as provided in the Memorandum Option and Order, WC Docket Nos. 18-141 et al. (rel. Aug. 2, 2019) and Report and Order on Remand and Memorandum Opinion Order, WC Docket Nos. 18-141 et al. (rel. July 12, 2019).

The amendment amends the interconnection agreement first approved by the Commission on   1/08/2003   (date)

in WUTC Docket No. UT-  023067   (original docket number).
