ERRATA TO ORDER 01

RE: *In the Matter of the Application of PNW Compost, Inc. For Authority to Operate as a Solid Waste Collection Company in Washington,*
Docket TG-230798

TO ALL PARTIES:

On December 8, 2023, the Washington Utilities and Transportation Commission (Commission) entered Order 01, Prehearing Conference Order and Notice of Hearing (Order 01) in the above-referenced docket.

It came to the Commission's attention that Order 01 contained an error. Paragraphs 1, 3, and Appendix A to Order 01 failed to include Commission staff (Staff) in the list of parties in this Docket. Paragraphs 1, 3, and Appendix A are amended in part to correctly reflect all of the parties.

Accordingly, Paragraph 1 is amended to read as follows:

1 **NATURE OF PROCEEDING.** On October 4, 2023, PNW Compost Inc., (PNW or Applicant) filed with the Washington Utilities and Transportation Commission (Commission) an application for authority to operate as a solid waste collection company in Washington (Application). On October 16, 2023, Waste Connections of Washington, Inc., and Waste Control, Inc., filed protests to the Application. On November 21, 2023, Staff of the Washington Utilities and Transportation Commission entered a notice of appearance.¹
