Mr. Young,

I am requesting a Stakeholders Meeting be scheduled by the Utilities and Transportation Commission related to Clutter Inc's Amended Petition, Docket TV-210535 dated August 30, 2022 to change the UTC WAC 480-15 and Intrastate HHG Tariff No. 15-C that provides me the necessary rules and rates to successfully operate my business.

Clutter Inc. is primarily a commercial storage business that believes that adhering to every provision of WAC 480-015 and Tariff 15-C puts Clutter Inc. puts them at a competitive disadvantage to other movers (everyone charging the same rate doesn't put them at a competitive disadvantage other than them not providing the specified tariff services) and in many cases requires Clutter to charge customers more than the cost of service for certain moves. As a regulated HHG carrier I do not see it that way. In prior years a rate study would be required for such a drastic change and re-writing of the Tariff, but I have not seen or been provided such a study.

Also, removing the Minimum Rate Band would preclude UTC action on the Movers Conference request for removal of the Maximum Rate Band

because removing both rate bands would require State Legislative approval taking months if not years to accomplish. Also, I would like confirmation from Washington State Department of Revenue as to what these changes would have on taxes we currently have to pay or may have to pay if implemented. Also, what taxing changes may occur in changing storage period and if any effect on SIT and/or the Bill of Lading. If it is found that any of these changes effect taxing, I believe the legislature may have to approve of any changes that are or effect taxes?

It would be unfair for me to come to a UTC "Open Meeting" before the Commissioners without first understanding the reasons for the proposed changes to HHG Tariff No. 15-C by Clutter Inc.

An Open Discussion at a Stakeholders Meeting to learn what is about to happen to me by these Clutter Inc. requested HHG Tariff No. 15-C changes if made permanent, needs to occur soon.

Please let me know when I might expect to receive an announcement of a UTC Stakeholders Meeting so I can get it on my calendar.
