Mr. Dunbar – Thanks for chatting with me this morning about ChargePoint’s petition to intervene in Washington UTC docket UE-220359. I followed up with one of our lawyers, and you do not have to withdraw the petition at this time. We will have to address it eventually, however. What I would suggest is that you plan on attending the open meeting where the PacifiCorp transportation electrification plan will be on the agenda, and orally withdrawing the petition then. That won’t happen anytime soon; I think it’s not going to be until the fall. In the meantime, I have added yourself, Jared Ballew and Matthew Deal to the service list for the docket, so you should be notified when filings get made in the docket (for instance, when the Commission issues the notice for comment that we discussed). You can also keep an eye on the docket on the Commission’s [website](#).
