Re: Dockets UE-220066, UG-220067, and UE-210918 Compliance Filings Multi-Year Rate Plan Annual Report (Attachment A) – First Supplemental -Corrected Multi-Year Rate Plan Metrics (Table 4) – Second Supplemental - Corrected

Dear Director Killip:

On August 30, 2024, Puget Sound Energy ("PSE") filed First Supplemental Attachment A and Second Supplemental Table 4 Metrics in compliance with Final Order 24/10 in Dockets UE-220066, UG-220067, and UE-210918 (Consolidated).

During a subsequent review of the 2023 Multi-Year Rate Plan Metrics, PSE identified an issue within the underlying code used to generate the recently published 2023 Energy Burden dataset, affecting the reported calculations for both Affordability Metrics and Energy Burden Metrics contained in Table 4 and Attachment A of the filing.

The issue stemmed from two customer features (bill and usage) within the 2023 Energy Burden dataset erroneously being aggregated at the contract account level instead of the customer ("business partner") level. This error has been fully addressed, and the necessary corrections have been made. The revised metrics, based on the updated and accurate 2023 Energy Burden data, are enclosed with this resubmission.
