



TO ALL PARTIES OF RECORD:

PLEASE BE ON NOTICE THAT the Commission DENIES Puget Sound Energy, Inc.'s (PSE) request that the date for Staff to make certain filings required by the Commission's Sixth Supplemental Order in this proceeding be deferred until February 2, 2001. Staff's Response to the Company's Request indicates that Staff is prepared to file on January 26, 2001, in accordance with the terms of the Sixth Supplemental Order. There appears to be no reason to delay the filing.

PLEASE BE ON NOTICE THAT the Commission believes it would be useful to have a reply by PSE to the Responses by Staff, Complainants, and PUD No. 1 of Whatcom County to PSE's Request for Continuance of Hearing.
