- 1 On December 3, 2007, Puget Sound Energy, Inc. (PSE), filed with the Washington Utilities and Transportation Commission (Commission) certain tariff revisions designed to effect general rate increases in its rates for electric service (Docket UE-072300) and gas service (Docket UG-072301) in this state. The proposed revisions provide for general rate increases of 9.50 percent for the electric tariffs and 5.31 percent for the gas tariffs. The Commission, by Order, has suspended the operation of the general tariff revisions and has consolidated the dockets pending hearing or hearings concerning all such changes, including whether the changes are fair, just, reasonable and sufficient.
- 2 PSE requests by motion that the Commission enter its standard form of Protective Order, amended to include provisions concerning the designation of documents as "Highly Confidential." WAC 480-07-420 and -423. A protective order will be entered in this proceeding.
- Hearing in this matter is being held pursuant to Part IV of RCW 34.05 pertaining to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission has jurisdiction over this matter pursuant to Title 80 RCW, having legal authority to regulate the rates, services, and practices of electric and gas utilities. Statutes involved, in addition to those previously cited, include those within RCW 80.01, RCW 80.04 and RCW 80.28 relating to rates, including but not limited to

- <sup>4</sup> The ultimate issues include whether the proposed tariff revisions are just, fair, reasonable, sufficient, and in the public interest. These issues may include consideration of alternative rate design or structure. In accordance with the provisions of RCW 80.04.130, PSE bears the burden of proof to show that the proposed tariff revisions are just and reasonable.

- Petitions to intervene should be made in writing prior to the hearing date or made orally at the hearing. The Commission prefers written petitions. Appearances will be taken at the prehearing conference.
