The Commission Staff has completed a second discussion draft of the Customer Notice Rules and the rules in Chapter 480-80 Tariffs, Price Lists, and Contracts. The proposed rules have been drafted based on written comments received and discussion at the June 12, 2001, stakeholder workshop. The second discussion draft includes provisions for electronic filing. The draft rules are available for inspection on the Commission's web site at www.wutc.wa.gov/991301. The Commission will send a paper copy of the draft rules or will send the proposal via electronic mail, if requested.

Commission Staff is planning to present the CR-102 Proposed Rulemaking regarding Customer Notice, Tariffs, Price Lists, and Contracts to the Commission at its **September 12, 2001**, open meeting. Please be very specific in your comments regarding text changes by suggesting preferred alternative language. If it appears there are policy differences that need to be addressed in another workshop prior to the CR-102 open meeting, a stakeholder workshop will be held on Thursday, August 23, 2001. You will receive notice confirming this workshop date if Staff sees the need as indicated in your written comments. Considerable discussion has taken place at prior stakeholder workshops regarding Part D - Price Lists. Unless new policy issues are identified, Staff does not intend to hold an additional stakeholder workshop regarding Part D - Price Lists.
