**NOTICE OF IMPENDING REVOCATION OF REGISTRATION
AS A TELECOMMUNICATIONS COMPANY
AND OPPORTUNITY TO REQUEST A HEARING**

Re: Revocation of Telecommunications Registrations for Failure to File Annual Reports and Pay Regulatory Fees for 2001; Docket No. UT-021600

TO ALL TELECOMMUNICATIONS COMPANIES LISTED ON ATTACHMENT A:

Staff of the Washington Utilities and Transportation Commission (“Commission Staff”) recently conducted its yearly review of annual reports and regulatory fees for telecommunications companies registered to do business in the state of Washington. As a result, Commission Staff identified the telecommunications companies listed on Attachment A as not complying with requirements for 2001. This notice is being served to all companies listed on Attachment A and their registered agents, if named, at their last known addresses. Year 2001 annual reports and regulatory fee payments for telecommunications companies were due no later than May 1, 2002.

WAC 480-121-060 provides that the Commission may revoke a company’s registration after notice and opportunity for a hearing, for good cause. Good cause includes failure to file an annual report or pay regulatory fees.

If any company listed on Attachment A wants to avoid revocation of its registration, within 30 days after the service date of this notice the company must either file an annual report and pay regulatory fees for 2001 or request a hearing to demonstrate why the company’s registration should not be revoked. If any company listed does not respond within 30 days, then the Commission will enter an order revoking the registration of that company as a telecommunications company without further notice. Unregistered companies are prohibited from providing telecommunications services in the state of Washington.
