Passenger Rules for "Stars and Stripes Shuttle" (Also referred to as "carrier")

Animals: Generally dogs, cats and other live animals or birds will not be carried. Exception: Service animals traveling with sight or hearing-impaired passengers will be carried free of charge. Service animals will not be permitted to occupy a seat, but must lie or stand at the feet of the passenger.

Fare: All seats are full fare for adults. Children under 12 may travel for free with 24-hour notification and accompanied by an adult family member.

Children: Protective car seats will be provided by the "Stars and Stripes Shuttle" on prior notification for children under the minimum age, weight and height as prescribed by the state of Washington and federal child safety laws. The "Stars and Stripes Shuttle" reserves the right to refuse to transport passengers who do not provide a child safety seat or fail to request one with 24-hour notification.

Objectionable Passengers: The "Stars and Stripes Shuttle" reserves the right to refuse to transport persons under the influence of drugs or alcohol, or who are incapable of taking care of themselves, or whose conduct or behavior may be objectionable to other passengers. The carrier also reserves the right to refuse carriage of any materials that the carrier considers unsafe and not in the best interest of the passengers.

Smoking and Tobacco Products: The "Stars and Stripes Shuttle" will not allow smoking of pipes, cigarest, cigarettes or the active chewing of a tobacco product to take place on the carrier.

Schedule Maintenance: The "Stars and Stripes Shuttle" will not be liable for delays caused by accidents, breakdowns, bad conditions of roads, snow storms, or other conditions (other conditions also include military emergencies, exercises or vehicle inspections that cause the entry gate(s) at Fairchild AFB to close or delay) beyond the control of the carrier and does not guarantee arrival at or departure from, any point at any specific time. The time schedules provided are schedules the carrier endeavors to maintain, but does not guarantee to be able to do so at all times due to conditions listed above.
