TO INTERESTED PERSONS:

Since 1979, the Washington Utilities and Transportation Commission has administered a small grant program called the Grade Crossing Protective Fund (RCW 81.53.281). The program is intended to assist railroads and local agencies in improving safety at public railroad crossings. Until recently, the grant was limited to upgrading warning devices at crossings and provided 60 percent of a project's cost. The remaining costs were apportioned between the railroad and road authority at 10 percent and 30 percent respectively.

During the 2003 legislative session, the legislature passed and the Governor signed into law HB 1352, Chapter 190, Laws of 2003. The new law amends RCW 81.53.281 to broaden the purpose of the Grade Crossing Protective Fund (GCPF) to include all rail safety projects that pose a high risk to public safety, including those that may not be related to public grade crossings.

The law also amended the GCPF apportionment system by waiving the match requirements for projects under \$20,000 or the first \$20,000 for projects that exceed that amount.

The Commission is creating a policy to provide guidance for the grant program in light of the changes. The workshop will provide Commission staff with information, opinions and ideas from interested parties about how the program can be designed and implemented. DOCKET NO. TR-031384 PAGE 2

Subjects included in the workshop may cover but are not limited to:

- Whether formal rules are required for administration of the program;
- Allocation of funds between projects in different categories (i.e. grade crossing v. non-grade crossing projects);
- Application process;
- The development or adoption of prioritization methods to determine which projects have the greatest net public safety benefits;
- Frequency of disbursement;
- Applicability of the GCPF to private grade crossings;
- The relationship between GCPF and the Section 130 Federal Grant Program.
