Dear Ms. Washburn:

In accordance with the Interpretive and Policy Statement issued on June 28, 1996 in Docket No. UT-960269, McImetro Access Transmission Services LLC (McImetro) hereby provides notice of its intent to adopt the terms of a previously approved interconnection agreement in its entirety. Specifically, pursuant to Section 252(i) of the Act, McImetro adopts the terms of the interconnection agreement between AT&T Communications of the Pacific Northwest, Inc. and Verizon Northwest, Inc., f/k/a GTE Northwest Incorporated, dated September 8, 1997, and all of its amendments to date, which have been approved by this Commission in Docket No. UT 960307. This adopted agreement as it applies to McImetro and Verizon Northwest should be read so as to replace any reference to AT&T or AT&T Communications of the Pacific Northwest, Inc. with McImetro.

The Agreement does not discriminate against non-party carriers. It is consistent with the public interest, convenience, and necessity. It is also consistent with applicable state law requirements, including Commission orders regarding interconnection issues. MCImetro respectfully requests that the Commission approve this Agreement expeditiously.

The Order on Arbitration Procedure also requests that a proposed order accompany the filing. MCImetro requests a waiver of that requirement, and is not providing one with this filing, as the Commission has, in the past, used its own format for Orders. If this is not satisfactory to the Commission, please contact me and I will forward a proposed order immediately.
