- Section 16 of Qwest's Performance Assurance Plan, or QPAP, provides for a review of certain performance standards, or performance indicator definitions (PIDs) every six months following the effective date of the QPAP to determine if any adjustments should be made to performance measures, benchmark or parity standards, or payment structures. The first six-month review period began on June 23, 2003, and ended in December 2003. On January 16, 2004, the Commission entered Order No. 05, Order on Issues Pending in First Six Month Review Period, in Docket No. UT-033020. The Commission opens a new docket and schedules this prehearing conference to commence the Commission's second six-month review of Qwest's QPAP.
- Hearing in this matter is being held pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission has jurisdiction over this matter pursuant to Title 80 RCW, and RCW 80.36.610(1), and 47 U.S.C. § 271(d)(3)(C) and 47 U.S.C. § 252(f), having a legal obligation under the Telecommunications Act of 1996 to continue to review Qwest's compliance with Section 271 of the Act and modification of Qwest's SGAT. Rules involved include those within chapters 480-07 WAC.
- The ultimate issues are whether and how Qwest's Performance Assurance Plan, or QPAP, should be modified pursuant to Section 16 of the QPAP during the Commission's second six-month review period, which begins in January 2004.
