Increases in the costs of all areas of business operation, including transportation, property taxes, and insurance, make up the balance of the requested increase.

If approved, the new rate would become effective June 15, 2006.

Washington Water Service Company understands and is sensitive to the impact of rate increases. We are continually looking for ways to cut operating costs and are committed to operating as efficiently as possible while providing excellent customer service and a reliable water supply that meets all water quality standards.

The proposed changes are summarized as follows:
