On July 19, 2006, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider possible corrections and changes to selected rules in Chapter 480-75 WAC, Hazardous Liquid, Gas, Oil, and Petroleum Pipeline Companies—Safety, specifically addressing WAC 480-75-300, WAC 480-75-450, WAC 480-75-630, and WAC 480-75-650.
