The commission believes that you have committed one or more violations of Revised Code of Washington (RCW) 81.04.380 and Washington Administrative Code (WAC) 480-15-570, which adopts by reference Title 49, Code of Federal Regulations (CFR) 382.301(a), using a driver before receiving a negative pre-employment controlled substance test result. RCW 81.04.530 allows penalties of five hundred dollars for every such violation.

As a result, the commission hereby notifies you that it has assessed penalties against you in the amount \$1,000, as follows:

On October 30 and 31, 2006, Investigator Leon Macomber conducted a terminal safety inspection on your company. Mr. Macomber found the following two drivers were operating a vehicle, although you did not receive a negative pre-employment controlled substance test result for them.

- Failauqa Helu. His first trip as a driver was on February 10, 2006. He was hired on February 5, 2006. There was no controlled substance test result found at the time of inspection.
- Nofoao Filimaua. His first trip as a driver was on December 27, 2005. He was hired on December 9, 2005. There was no controlled substance test result found at the time of inspection.

This information, if proved at a hearing and not rebutted or explained, is sufficient to support the penalty assessment.

Your penalty is due and payable now. If you believe the violations did not occur, you may request a hearing to contest the penalty assessment. If there is a reason for the violations that you think should excuse you from the penalty, you may ask for mitigation (reduction) of this penalty. See RCW 81.04.405.

You have the right to present your request for review or mitigation at a hearing, but you are not required to do so. If you do, the commission will review the evidence supporting your request in an informal hearing, called a Brief Adjudicative Proceeding, before an administrative law judge. The administrative law judge will consider your plea and notify you of his or her decision.

You must act within 15 days after receiving this notice to do one of the following:

- Pay the amount due.
- Request a hearing to contest the occurrence of the violations.
- Request mitigation to contest the amount of the penalty.

Please indicate your selection on the enclosed form and send it to the Washington Utilities and Transportation Commission, Post Office Box 47250, Olympia, Washington 98504-7250, within FIFTEEN (15) days after you receive this notice.

If you do not act within 15 days, the commission may refer this matter to the Office of the Attorney General for collection. The commission may then sue you to collect the penalty.
